	<ul style="list-style-type: none"> <li>Government Related Entities (<b>GREs</b>)</li> </ul>	A Government entity or a supranational authority recognized by the CMA.
<ul style="list-style-type: none"> <li>Institutional DPMs</li> </ul>	Saudi institutional investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).	
GCC	<b>Individuals</b>	GCC natural person
	<b>Institutions</b>	GCC legal person with a commercial registration certificate (corporate or mutual fund), in addition to GCC government entities.
	<b>GCC DPMs</b>	GCC investment account (institutional or individual) in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).
Foreign	<b>SWAP Holders</b>	Authorized Person with the permission to enter into SWAP agreements to transfer the economic benefits of its ownership of shares in Saudi companies listed on the Saudi Stock Exchange to its non-resident foreign clients.
	<b>Foreign Residents</b>	Foreign investors domiciled in the Kingdom with a valid residency permit (Iqama) (excluding GCC nationals).
	<b>QFIs</b>	Qualified Foreign Institutional investors registered with the CMA in accordance with the QFI Rules, to invest in shares listed on the Saudi Stock Exchange.
	<b>Foreign DPMs</b>	Foreign resident investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).

## Highlights

The total value of shares traded for the week ending 17 March 2016 amounted to SAR 26.57 billion, decreasing by 19.29% over the previous week; while total stock market capitalization reached SAR 1,472.04\* billion at the end of this period, increasing by 0.35% over the previous week.

- The total value of shares purchased by “Saudi Investors” during this period amounted to SAR 25.39 billion representing 95.58% of total buying activity, and sales of SAR 25.29 billion representing 95.20% of total selling activity. Total ownership of “Saudi Investors” stood at 93.22% of total market capitalization as of 17 March 2016, representing an increase of 0.03% from the previous week.
- The total value of shares purchased by “GCC Investors” during this period amounted to SAR 0.523 billion representing 1.97% of total buying activity, and sales of SAR 0.517 billion representing 1.95% of total selling activity. Total ownership of “GCC Investors” stood at 2.50% of total market capitalization as of 17 March 2016, representing an increase of 0.05% from the previous week.
- The total value of shares purchased by “Foreign Investors” during this period amounted to SAR 0.651 billion representing 2.45% of total buying activity, and sales of SAR 0.757 billion representing 2.85% of total selling activity. Total ownership of “Foreign Investors” stood at 4.28% of total market capitalization as of 17 March 2016, representing a decrease of 0.08% from the previous week.
